

# STOP SIGN ORDINANCE 2020

## Town of Stella

## Oneida County

The Town Board of Stella, Oneida County, Wisconsin, does hereby ordain and create the following Ordinance to establish stop signs in the Town of Stella.

Under the powers granted to this government unit by the Wisconsin State Statutes 349.06, the following street and roadways of the Town of Stella shall be designated and marked with official stop signs to control traffic on the intersections stated. The Applicable stopping rules as set forth in Wisconsin Statutes 346.46 (and subsequent enactments) and the penalty provisions of 346.49 (and subsequent enactments) are hereby adopted and by reference made a part of this Section as is fully set forth.
